 - \$460K is definite funding toward the project and we are confident that we will be able to receive more funding for future projects.
 - We have requested full design plans from NRTC in the contract.
 - This can be called a "network design."
 - Language around "cash-flow positive" vs "profitable"
 - Want well informed language that people can understand.
 - Who is the target audience? What is the objective behind a press release?
 - The citizens of the NEK and report the progress
 - Decimated via press release and could be put on media or front porch forum
 - Will continue a distribution strategy discussion at the next meeting.
