7:05 - Report of 2020 activities and 2021 plan -Evan Carlson, NEK Broadband Chair

Evan gave a brief introduction to the meeting and agenda

#### For 2021

- NEK Broadband is a community Union district with 47 towns, hoping to get the rest of the towns involved very soon
- We received the CARES grant to build in Concord and waterford
- Completed the Business Plan with NRTC
- Received 276,000 through H315 for Preconstruction to further planning efforts and the pilot project
- Selected Waitsfield Champlain Valley Telecom to be our network Partners, appointed Christa Shute as interim Executive Director, received USDA RDBG grant to expand pilot project
- Received ownership of the state fiber assets, in the process of starting construction in Concord, fiber on poles in a couple of weeks, we have ordered Fiber for the network build and applied for more grant funds.

#### For 2022

- Completing the Executable Project Plan
- Ordering for First Construction Materials
- USDA grant work to complete
- Pole attachments and rideouts will be happening
- Prework for the construction season
- Will be hiring multiple crews to get the work done, will be doing marketing, and will have some customers online, will be trying to increase the take rate throughout the

- region to aid 2022+
- For 2023 and beyond we will be looking to go to the bond market and complete the builds and mission.

7:20 - Financial Report - Christa Shute - NEK Broadband, Executive Director

Christa gave an overview of the Budget for 2021

- We were able to raise 1.4 mil for 2021 through various grants
- The expenses increased as well. (374,471.00)
- We were unable to get VEDA loans or matches, we will look to that in the future Capital investment:

The proposed budget for 2022 was given.

• Preconstruction cost will cover salaries.

#### 7:30 Public comment and questions

- Rep. Williams- Branching out into rural areas, are you hitting the Class 3 roads, all of the population?
  - Christa- Every address that is powered by electric utility. The build is 4-5
    years, it could take longer. We are hyper-focused on the unserved and
    underserved. We want to take care of as many of those as we can.
- Rep Williams- if they are off- grid they are not eligible?
  - Christa- Yes, the funding is tied to on-grid addresses. Off-grid would be extremely hard due to costs, but the Organization, hopes to find different ways to reach them if we can. Perhaps using wireless entities at the end of the Fiber network.
  - Christa- we are also working with the utilities on customers who may want power to their homes
- Lonny- when will it come to Guildhall?

- Christa- We have identified every address 39,000 premises, and the solution to get to them and locations for the backbone. We have identified the cabinet locations. The next part of the process will be to look at where we are going. After the Executable Project Plan is complete, we will have a better idea.
- Lonny- is there fiber on 102?
  - Christa- There is and the NEK Broadband will be taking that fiber over and will be owned by NEK Broadband. We are looking at how we can leverage the state fiber and bring service off the state fiber as quickly as possible, while continuing to build.
  - Christa- the fiber exists, but is not lit. We are issuing an RFP for the materials
     next week. The lead times are currently very long. It may be April or later.
- Lonny- how will we be notified when Fiber is available?
  - o Christa- get.nekbroadband.org to stay updated on the build.
- Kristen- our mission and capacity is to serve grid tied addresses within the member towns, but we do not have funding for towns that are not in our CUD. Towns include Granby, Lemington, Bloomfield, Victory, and Norton.
- Rep. Williams- who do I send to the Select Board to get answers to our questions?
  - Evan- Myself or Michael Strait.
  - Christa- there is no cost for the municipality, there is no debt that can go to the municipality, there is no required cost for member towns. There will be a standard cost for service.
  - We are thankful for those who reach out to their towns to join the CUD.
