Executive Director Update

Discussion Summary:

- Christa gave a high-level introduction of the Business Model/Strategy and the overall next steps of NEK Broadband for the representatives. The NEK CUD has purchased approximately 1000 miles of fiber and will be placing purchase orders for construction materials tomorrow to get ahead of supply/demand issues. The goal is to continue construction in April. The high-level design is for all of the towns in the Northeast Kingdom and Wolcott. The high-level design has been completed and the NEK CUD has been in the process of developing an Executable Project Plan (EPP), which is a more detailed business plan. The EPP will aid the detailed design plan for each Service Area.
- NEK Broadband is now an Internet Service Provider (ISP). The CUD celebrates this accomplishment alongside our partners WCVT and NRTC.
- NEK Broadband is applying for a construction grant recently approved by the legislature. Having 100% participation increases our funding and ability to reach the unserved and underserved homes in the Northeast Kingdom.
 - How can the delays effect the project?
 - As pricing and lead times fluctuate the CUD is grateful to have secured the proposed 1000 miles of fiber. It may effect the purchasing of construction materials, which is why the CUD is trying to move swiftly and efficiently to make those purchases while

balancing the price premiums with the budget. The NEK CUD will purchase for the immediate construction season. The CUD is looking to issue an Request For Proposal (RFP) for Network Equipment near the end of January. In the meantime, WCVT is purchasing customer equipment on our behalf to mitigate the current shortages in network equipment
