New Business - 70 Minutes

5:40 - COVID-Response Connected Community Resilience Program 2nd Grant Round Proposal (For Vote)

- The CARES funds (given by the legislature to the CUDs) needs to be spent by the end of the year.
- \$300K would be distributed equally to all of the CUDs. The NEK CUD could receive
 more if others do not receive it, given that the deadline for the grant proposals is
 not extended.
- Tilson was asked to present two proposals for this funding. One for \$300K and one for \$460K
- The first proposal given would service to 44 locations with fiber. The second is an

- additional 36 locations
- This project would get customers connected to fiber by the end of the year
- Tilson has a pre-approved project with Lunenburg with the state and proposed an extension of the project into E. Concord for their proposal to the NEK CUD.
- The proposal was set with the idea that Green Mountain Power would provide make-ready costs, and the proposal is at risk.
- Tilson would like to move forward with the project.
- Conditional Resolution: If Tilson can make the proposal happen within the
 confines of the CARES Grant and Tilson assumes all of the risks related to the
 costs. The CUD will not be assuming any costs that GMP would not be able to
 provide.
- Motion made to approve the grant application for the Connected

- The Governing Board believes the Executive Committee can approve the final agreement with Tilson without a full Governing Board special meeting. This will speed up the ability to move on the project when needed.

- A big thank you to the Finance Committee and Kristen Fountain for pulling together the drafted budget.
- The draft budget is largely based on previous meetings.
- It is an administrative operating structure
- VEDA is in a capital proposed budget. \$4mil with a loan guarantee behind it.
- Christine proposed when we get out of RDOF and receive the feasibility study. We
 can identify areas we want to move to and provide oversight for the construction.
 We would then start RFP for EPC (Engineering, Procuring, and Construction) vendors
 and construct \$4mil worth of assets next year.
- 1.5 mil of CARES funds and 1.5 mil has to be appointed by June given by the state.
- Footnote amendment to be made to the proposed budget: dependent upon favorable results from the feasibility study.
- The annual report conveys what has taken place this past year and will be presented by Public Hearing at the next Governing Board Meeting, November 12th.
 Notices will be given in the next couple of days
- Paul Fixx asked about the \$90,000 of "undeposited funds." The \$90,000
 Undeposited funds has been deposited into the account and Kristen will update the budget before the meeting

Informational Handout for Remote Public Meetings

Remote Public Meetings

All public body meetings for the NEK Community Broadband CUD will be conducted remotely via electronic means for the duration of Governor Scott's State of Emergency declaration.

Whenever feasible, the public will also be able to access and participate in the remote meetings by dialing in through telephone.

Accessing a Meeting

Please refer to each public body's notice and agenda for information on how to access a remote meeting. Please note that whether you join by telephone, computer, or device, you may be put on hold or in a waiting "room" until granted access to the meeting. You also may be muted or restricted from using any chat function until the public comment portion of the meeting.

Participation

All meetings will be conducted in accordance with the respective "Rules of Procedure" of each public body, to the extent practicable. The public body will follow its agenda and allow public attendees to participate through voice (audio) means where feasible or alternatively using any chat function during the designated public comment periods on the agenda and at other applicable times as needed.

Initially, the meeting's host/organizer will mute all participants that are not members of the public body. This is necessary to control background noise. The host/organizer will then unmute participants or allow participants to unmute themselves when invited to speak by the Chair of the public body.

Please review the following guidelines:

- The Chair will invite comment:
 - o during the time designated on the agenda for public comment;
 - o after the public body discusses each agenda item;
 - before the public body takes action;
 - o during any open public comment period, if applicable; and
 - o other times as determined by the public body.
- When a participant/attendee is unmuted, they must state their name before commenting.

If the public body successfully moves to enter an executive session, the meeting's host/organizer will then place everyone that is not part of the executive session on hold or a virtual waiting "room." This will prevent attendees from hearing or participating in the meeting during the duration of the executive session. When the public body exits executive session, the host/organizer will then grant access back to the remote meeting.

When the public body adjourns the meeting, the host/organizer will end the electronic meeting by turning off/closing the remote meeting software. Attendees will be automatically disconnected.

Minutes and other public records that were part of the meeting will be made available in accordance with VT's Open Meeting and Public Records Laws.
