7:05 - Report of 2020 activities and 2021 plan -Evan Carlson, NEK Broadband Chair

- CUD focused on bringing affordable internet to the rural areas of the NEK. We currently have 32 towns. We hope to extend across orleans and essex. As we were closed down for pandemic, the need was highlighted for those who needed to do online schooling and working.
- March 27th CARES act, legislature began looking into how to improve the community needs. All of our governing and meetings were moved to zoom.
- April 30th CUD held an organizational meeting, establishing the Executive
 Committee (ppl) and the bylaws. Clerk Annie/Jami Treasurer Dave
- May 6th NEK CUD recognized by the legislature.

- May created Finance and Tech committee
- June the NEK adopted a mission statement, (recording) operating models
- Operating model: hybrid public/private model, the CUD would not be an ISP, but would help service the fiber network.
- CUD joined with Tilson, VELCO, GMP in the RDOF auction. Signed to join VCUDA to

- help inform policies across the state.
- August: Finance Committee's 2020 budget was approved. To hire Christine Hallquist
 as the Administrator and Jami Jones as the Clerk. Approved to connect 100
 addresses with Kingdom Fiber.
- October: adopted the draft budget and annual report, approved second Connected
 Community with Tilson, will connect 100 address to fiber
- November: Tilson will give us a feasibility study and will move ahead with a business plan
- Next year: looking forward to getting addresses connected, building up the network and working with an ISP long-term to get others connected.

7:20 - Financial Report - Christine Hallquist - NEK Broadband Administrator and Treasurer

- This year: The majority of funding is coming from the State of Vermont through the grant processes. The bulk of the money will be spent on fiber. Low overhead expenses.
- Next year: additional fundraising for administrative and overhead costs. Will leverage our current assets and the VEDA to get a \$4mil loan. This would potentially give 1000 installations. We will have a foundational plan that will be driven by the business plan made with Tilson. The NEK will build a 3 year and a 10 year capital plan from the business plan. Other funding are other grants, a few private equity, low interest loans (cobank, cbc- funding rural telecommunication build-outs loaning 70 percent of the capital business plan). The business plan will be revised annually and will guide us for the rest of the year.

7:30 Public comment and questions

• The NEK will need multiple offices to give to all the service areas to deploy fiber, assets and people. The cost vs customers for a single central office depends on the general physical area (1000 in an urban) varying depending on the needs. The

- distance that light can travel (15-19mi radius) around an office that you can capture people. The cost projected is an all in cost. We will be working with VCUDA to see what the standard needs to be set for the deployment of the fiber.
- Utility fiber: we are in discussions to work with utilities and see our missions as aligned. Green Mountain Power is interested in getting fiber to every home and business to achieve climate change goals. This sort of thinking with the utilities creates an opportunity with the CUD.
- The NEK CUD largest asset is community support. We need to be able to get the
 word out and receive communications to the surrounding communities. Attendees
 are able to go to their town planning commissions and select boards and look into
 what their plans are for the internet in their area. Our facebook page:

- Some areas of the NEK are not "underserved" but it is not a good solution for lower income addresses. There is an effort in the FCC to acknowledge that some addresses are served and some are not. The NEK CUD board may be able to bring this concern to the legislature next year.

Informational Handout for Remote Public Meetings

Remote Public Meetings

All public body meetings for the NEK Community Broadband CUD will be conducted remotely via electronic means for the duration of Governor Scott's State of Emergency declaration. Whenever feasible, the public will also be able to access and participate in the remote meetings by dialing in through telephone.

Accessing a Meeting

Please refer to each public body's notice and agenda for information on how to access a remote meeting. Please note that whether you join by telephone, computer, or device, you may be put on hold or in a waiting "room" until granted access to the meeting. You also may be muted or restricted from using any chat function until the public comment portion of the meeting.

Participation

All meetings will be conducted in accordance with the respective "Rules of Procedure" of each public body, to the extent practicable. The public body will follow its agenda and allow public attendees to participate through voice (audio) means where feasible or alternatively using any chat function during the designated public comment periods on the agenda and at other applicable times as needed.

Initially, the meeting's host/organizer will mute all participants that are not members of the public body. This is necessary to control background noise. The host/organizer will then unmute participants or allow participants to unmute themselves when invited to speak by the Chair of the public body.

Please review the following guidelines:

- The Chair will invite comment:
 - o during the time designated on the agenda for public comment;

- o after the public body discusses each agenda item;
- before the public body takes action;
- o during any open public comment period, if applicable; and
- o other times as determined by the public body.
- When a participant/attendee is unmuted, they must state their name before commenting.

If the public body successfully moves to enter an executive session, the meeting's host/organizer will then place everyone that is not part of the executive session on hold or a virtual waiting "room." This will prevent attendees from hearing or participating in the meeting during the duration of the executive session. When the public body exits executive session, the host/organizer will then grant access back to the remote meeting.

When the public body adjourns the meeting, the host/organizer will end the electronic meeting by turning off/closing the remote meeting software. Attendees will be automatically disconnected.

Minutes and other public records that were part of the meeting will be made available in accordance with VT's Open Meeting and Public Records Laws.
