Updates from Executive Director

- Discussion Summary:
- **Funding:** We have been approved through the VCBB in the Preconstruction Grant to receive additional \$1.35 million in funds. The Construction Grant application has been sent for \$16mil to the VCBB. It pays for the first 230 miles of construction and 500 miles of materials. It is scheduled for review one week from Monday. Next steps are to apply for the VEDA Loan. This will help if the CUD needs a match for funds or funding outside of the grants. We have received a letter of support from our congressional delegation. It has been sent to the Secretary of the USDA and the group that will be reviewing the USDA Grant. We look forward to future updates.
- **Resources:** Christa gave an overview of the new hirees/contractors that we will be working with. NEK Broadband will be posting a job description for Grant Manager/ Bookkeeper. There are 2 open seats on the Executive Committee if any board member would like to join. Executive Committee meets on the First and Third Thursdays at 4pm (EST).
- **Construction:** NEK Broadband made the permanent connection between VELCO and Waitsfield. We will start billing next week. We will start servicing those in Concord who are interested and signed up via get.nekbroadband.org. Make-Ready apps have been sent in for new parts of the backbone including the USDA ReConnect area.
- Materials: Lead times on equipment extend 6-10 months. We have put out and received RFPs for Network Materials and Construction Materials. The goal remains a 5 year build. The major constraint is labor supply. We have been focusing on Workforce Development and will continue to do so in a long-term perspective.

New Business

Affordability Group Update

• **Discussion Summary:** The Affordability Group has been established. Claire Polfus gave a quick update for the Affordability Group. The Group discussed the definition of "Affordability," the current available assistance, and how to bridge a gap between differing income brackets. The group is looking into possible funding options, i.e. a sliding scale, a universal service fund, and what effect that has on the business model. The group will be meeting on the 2nd and 4th Thursdays of the month at 4pm, and will bring more information at the next board meeting. WCVT has invited the NEK to a presentation on ACP (Affordable Connectivity Program) which will be recorded and uploaded into the "Affordability" folder.

Conflict of Interest Policy

• **Discussion Summary:** Jonathan Baker put together a Conflict of Interest Policy largely derived from another private organization. It was positively reviewed by NEK Broadband's general counsel. There will be edits made to the policy for more clarity. The policy will be revised and reviewed by the Executive Committee to include clarification on "grantees," "independent contractors," possible "Exemption Clause," and "Undivided Loyalty" languages.
