**Discussion Summary:** Christa encouraged those who would like to get further involved to begin by coming to and participating in Executive Committee meetings, and reiterated that prior knowledge about broadband is not critical to serving because each person brings important perspectives from their lives and their towns to the work.

### **Preliminary Vote to approve the 2025 NEKCV budget**

**Discussion Summary:** Christa said that at the Governing Board meeting in December is when there will be a final vote on the budget that we will be held accountable to for 2025 unless we come back to the Board and ask for modifications if necessary. Based on the Request for Application that was posted by the Vermont Communications Broadband Board and on the fact that we will have a change in administration in Washington, we are currently doing some modifications to decrease construction costs.

Denise noted that the amount for Construction Costs on the Annual Report that was sent out to towns inadvertently included the administrative costs as well. The correct figure for the Capital Grant Revenue (Construction Costs) is \$16,607,798 for what we're projecting through the end of 2024. For next year's proposed budget, Denise noted that we will be generating revenue over and above our expected costs. She also noted that Operations Revenue projected for 2025 based on our customer increase of just over two million dollars and Administrative Grant Revenue covering the administrative costs are 9.26% of the total expenditures which for a construction-based business is remarkable. Operational costs include running the three warehouses that we currently have in place. Our administrative

costs will increase because we plan to ramp up our staffing from 11 to over 20 which will be required for the amount of construction that we plan to do. This will include bringing on some of our own installers and lessening our vendor costs. We still anticipate that our customer revenue will cover our plant operations and our plant expense, not all of our admin, staffing, occupancy, etc. We will make clear to you for the final budget proposal for our December meeting exactly what is shifting.

Forecasting

By end of 2024 - 1245 customers, 665 miles built. (Actual construction costs were less than budgeted this year because of the inability to get makeready licenses in the areas that we had grant funding for.)

By end of 2025 - 2270 customers, and customer revenue of 2,047,769

By end of 2025 - Phone Customers - 360 residential and 40 commercial

By end of 2025 - 577 miles built but number is likely to change depending upon grant funding allocation.

Our overall goal is cost efficiency and prudent expenditures of the funds and making the CUD function at its fiscal best.

Christa noted that we have made an offer to someone for our CFO position who has indicated he will accept it and that we will start our new financial system, Elation, in December. These additional resources will help us bring more consistent information to the Executive Committee and the Governing Board.
