Roll Call Final Vote on NEK Broadband-CVFiber Merger Motion outlined above: 37 in favor, one abstention for NEK Broadband. CVFiber Merger Vote was unanimous with 14 votes.

### Comms Merger Plan:

- Tomorrow, a landing page will be put on each of our respective websites. It will include the final merger plan; background context, CUD alignment, the "why" behind the merger, the importance of BEAD; an FAQ section with a w; ay to ask questions using a <a href="mailto:info@nekcv.org">info@nekcv.org</a> email address.
- Notice will go to our Town clerks and will include a link to the landing page, and will give them redirect links to get more information.
- We have a directory update request to change our listing on the dept. Of Public Service/CUD website
- We will update our signature lines with the new combined NEKCV logo.
- Both websites will be maintaining minutes of the relevant meetings. How soon will CVFiber folks move over to the Google domain? That conversation will start tomorrow. Chuck Burt offered to help
- Customer Update: CVFiber Take Rate: 414 customers, 479 customers for NEK; we are working towards a 10% increase by Nov. 1. Strategies: postcard mailing; outbound calling (WCVT does it now for those in service who haven't started the install process); called to those who are not pre-registered. Coffee & Connectivity events, sponsoring a concert and final Fridays. We have Board members who are canvassing and knocking on doors; we are working on our seasonal and underground policy.
- Excited that CL03 is ready for scheduling final installs; we'll begin marketing push at the beginning of Sept. CVFiber is on the cusp of reaching its 500th customer so a celebration is being planned. We'll also be enhancing and aligning the customer journey including CrowdFiber messaging, email automation, resources pages (that will be duplicated on the NEK site) we've received 132 responses to one month later

survey. A Content calendar for 2024 has been created to implement internal processes on behalf of both brands. We will be monitoring metrics to guide us in the right direction.
