Summary

The ideal candidate for this BEAD Project Manager position will be a highly motivated and detail-oriented individual, possessing a comprehensive understanding of project management best practices preferably with either a background in managing federally funded programs or infrastructure grants and telecommunications infrastructure and/or construction.

This role will work closely with our Construction Manager, Director of Operations, Executive Director, vendors and other stakeholders to ensure all deliverables are on time and within the allocated scope and budget. The selected candidate will have a proven track record and extensive knowledge of best practices in project tracking and management.

Key Responsibilities

- Develop comprehensive project plans and schedules that are aligned with project objectives and grant requirements.
- Manage project progress, identify potential risks, and implement mitigation strategies to maintain project timelines.
- Coordinate and lead cross-functional teams, including engineers, contractors, and third-party vendors, to ensure smooth project execution.
- Monitor construction and grant budgets. Track Sub-Contractor project status and manage the invoice reconciliation process.
- Work with the Construction Manager to ensure compliance with industry standards, local regulations, and company policies throughout all construction phases.
- Prepare and present regular project updates to stakeholders, including senior management.
- Facilitate clear communication between all project stakeholders and promptly address any issues or concerns that may arise.
- Conduct post-project evaluations and apply lessons learned to enhance future project delivery.

Grant & Regulatory Compliance

- Ensure compliance with all BEAD program requirements, NTIA guidance, state broadband office requirements, labor standards, environmental regulations, and reporting obligations.
- Maintain accurate project documentation and records for audits and reimbursement requests.
- Coordinate required reporting related to grant performance, financial tracking, workforce compliance, and build progress.
- Support preparation and submission of reimbursement documentation and grant deliverables.
- Monitor prevailing wage, Buy America, permitting, and environmental compliance requirements.

Documentation & Reporting

- Maintain detailed project records including schedules, permits, contracts, change orders, compliance documentation, and construction updates.
- Prepare regular progress reports, dashboards, and presentations for leadership and funding agencies.
- Support audit readiness and grant closeout documentation.

Qualifications

- Bachelor's degree in Construction or Business Management, Civil Engineering, Telecommunications, or a related field (or equivalent experience).
- Extensive experience (5+ years) in overseeing large-scale construction projects, preferably within the broadband or telecommunications sector, or a background in a construction-related field.
- Experience managing federally funded programs or infrastructure grants strongly preferred.
- Excellent leadership, organizational, and communication skills.
- Ability to manage multiple projects simultaneously and deliver results under tight deadlines.
- Valid driver's license and willingness to travel to project sites as needed.
- Additional Qualifications but not required:
 - Strong knowledge of fiber-optic infrastructure, network deployment, and construction methodologies.
 - Experience with project management tools such as Smartsheet, Google Sheets, Excel, and MS Project, or similar software.
 - Understanding of permitting processes, local regulations, and compliance requirements.
 - PMP, PRINCE2, or similar project management certification is preferred.

Preferred Skills

- Experience in tracking and reporting on Scope of Works.
- Knowledge of BEAD, NTIA, broadband grant compliance, and federal funding requirements preferred.
- Understanding of preconstruction planning, construction management reporting, and post-construction concepts.
- Skills in managing and aggregating large datasets from various funding sources to report on status and risk.
- Familiarity with budgeting and financial management principles.
- Strong problem-solving skills and meticulous attention to detail.
- Some experience with GIS mapping tools and CAD software.
- Knowledge of both Outside Plant (OSP) and Inside Plant (ISP) construction.
- Ability to analyze data and prepare detailed reports and presentations.
